Solicitor: The Loan RFP is still under negotiations for a better rate and return.

The Solicitor recommends Council bid out Labor and Equipment Rates for 2015-2016 which is something typically done by municipalities to save money. In the event of an emergency there is no time for competitive bidding so this provision allows that work can be completed at a cheaper rate.

President Gregory noted that for the Brookhill project it was difficult to find bidders and this will eliminate that problem.

Currently Hazle Township, Foster Township and White Haven utilize the bidding process.

Councilwoman Hawk questioned what if the contractor is too busy. The Solicitor replied that as part of the bid they must be available to the Borough.

Councilman Gallagher equated the process to emergency road service where they must respond in a certain amount of time.

Councilman Fuccile advised the Christmas in Conyngham Committee need to let the Borough know the amount of electricity needed for each vendor. The Christmas tree lights will be installed. President Gregory noted commercial grade LED lights were purchased to conserve energy.

Grants: The interim report for the WREN grant was submitted on November 14, 2014. Initial amount has not been expended.

Notification was received today that the Borough did not receive the ARLE grant for Sugarloaf Avenue.

All the paperwork has been received for the LSA grant and the contacts have been revised to reflect new officials. Primary contacts are President Gregory and Councilman Gallagher. The Borough can seek reimbursement from the \$163,000.00 funds for building renovations already completed. The scope can also be modified for the remaining renovations.

Solicitor recommended submitting the Sugarloaf Avenue project for the upcoming LSA Grant.

Luzerne County Block Grant will be awarded soon.

President Gregory noted that it was stated in the letter the Borough received regarding the ARLE grant that the project submitted was worthwhile and should be considered.

It is the Solicitor's recommendation to submit as joint grant with Sugarloaf for LSA funding which would require a co-op agreement.

President Gregory added that the paving at the end of Sugarloaf Avenue should be tied in as well.

Shade Tree: Discussion ensued over the tree trimming since two trees scheduled for removal were not taken down. Councilman Jones noted the workers were relocated due to severe storms.

Councilman Gallagher will submit for tree maintenance grants which are matching grants.

COG: Report was given on the Municipal Auction. \$3,300.00 was raised for the COG. MCOG is one of a few COGs that do not pay dues. The municipal auction will be held again in 2015. Members have been invited to attend a Land Bank and Blight Summit on December 3, 2014 @ 6:30 pm at Penn State Hazleton Campus. The second event is an informational meeting regarding Luzerne County's decision to allow municipalities to keep 100% of the money recovered from delinquent tax collection at the Pines Restaurant @ 6:00 pm on December 10, 2014. Vice President Schneider explained that years ago a percentage was withheld from the municipalities however now they are proposing the collection fee be passed on to the delinquent taxpayer.

<u>Police Committee:</u> Councilwoman Hawk feels the part time hours of the police department should be reduced to 25 hrs. Discussion will continue at the December 8, 2014 session with the Mayor and Police.

Discussion ensued on inviting the Mayor and Chief to December 8, 2014 meeting. The attendance of the Mayor was in question.

Old Business: Councilwoman Hawk questioned why the Electricity budget was increased by 3%. Contract was signed with Mr. Clifford why would cost increase. President Gregory advised transmission fees can go up. Treasurer Blasé will continue to look at figures.

President Gregory advised Council will continue to replace lights with LED's.

Councilwoman Hawk questioned if we have received the subpoenas and set a hearing date. Solicitor advised due to budget meetings, work session, regular meeting and potentially special meeting the hearing will be held in January however records can be subpoenaed now. Discussion ensued over the subpoenas. Councilman Gallagher added the CBA has been pushing to be reimbursed by the LSA Grant for work completed.

President Gregory advised the Complaint has been filed against Rizzo, Temborski and Powell on November 10, 2014 therefore this issue may be resolved prior to subpoena hearing.

Vice President Schneider advised Council must follow through.

Solicitor will prepare subpoena for documents for the President's signature with 20 day response time.

President Gregory would like to set up a meeting with Ms. Manchell from Verizon Wireless to invite them to the December 8, 2014 meeting. Solicitor reviewed proposed lease.

Councilman Fuccile questioned whether this can be set up as a committee meeting and report back to Council. Committee will be comprised of President Gregory, Councilman Gallagher and Councilman Jones.

<u>Catch-All:</u> Councilwoman Hawk questioned the correspondence received regarding citizen's requests for EDUs.

President Gregory explained that at the CBA meeting it was stated they do have 3-4 EDUs.

Councilman Gallagher added two requests have been received. The Peters' Estate made a request for additional EDUs to make the property more marketable. The second request was from the Cara family regarding a proposed subdivision in need of EDUs that were acquired previously from Sugarloaf.

Discussion ensued over the transfer of EDUs between Sugarloaf and Conyngham which will no longer be an issue when the Joint Authority takes over.

President Gregory requested clarification on the amount of EDUs remaining. Councilman Gallagher will approach DEP to determine available EDUs.

President Gregory requested a step by step process of the procedures for development be drawn up so the residents have a clear understanding of what is expected of them.

Solicitor stated the most alarming part of this situation is that between two communities four new homes are proposed for development however the development is being stifled by the CBA over EDUs.

<u>Public Comment:</u> Carol Zamba gave a brief overview of the feral cat program. Twenty eight feral cats were spayed or neutered during five clinics between August and October. Eighteen of the operations were funded by public donations while ten animals were funded privately. This program has brought the feral cat population into a controllable situation. Ms. Zamba requested \$500.00 be placed in the budget for 2015 for the program. Pet owners were reminded that if they allow there cats to roam outdoors they must wear a collar to distinguish them from the feral cats.

Councilwoman Hawk thanked Ms. Zamba for her efforts. Discussion ensued over the spay/neuter program versus vector control as well as the use of public funds for the program.
