Conyngham Borough Council met in Regular Session on Tuesday, March 17, 2015 at 7:04 p.m. in Council Chambers, Municipal building, 215 Main Street, Conyngham, Pennsylvania. Rizzo Subpoena was issued requiring a compilation of documents for time served on Council and the CBA regarding the \$80,000.00 of Borough funds transferred to the Authority. A document response was received and Council must determine whether the information if sufficient or a hearing will be needed.

President Gregory advised it would be prudent to discuss in Executive Session.

The Solicitor addressed Council and Zoning Officer Rick Wech as to the need for clarification of the permit process. The current process includes Building Permits being issued by both the Zoning Officer and BCO Barry Isett & Associates, Inc. Council believes only UCC permits should be required as called for in the Code. Fees will be commensurate with service provided. A required permit list will be obtained from Barry Isett & Associates, Inc.

<u>Valley Regional:</u> Conyngham had two (2) Fire and Rescue and seven (7) EMS calls for the month of February.

Recreation: Recreation Board President Thomas Licurgo addressed Council regarding the necessity for any employee age 14 yrs old and up working for the park program to obtain State Police Clearance (\$10.00), Child Abuse Clearance (\$10.00), and FBI Clearance (\$27.00). Jacquelyn Carrelli will again head the Park Program.

<u>Convngham-Sugarloaf Joint Municipal Authority:</u> A WREN Grant is available to apply for \$3,000.00 for Source Water Protection. Applications are due Friday, March 20<sup>th</sup>. A joint grant between Sugarloaf & Conyngham Borough can be obtained to develop an emergency protection plan for the wells.

The LSA Gaming Grant has been secured by the Borough for the Authority Building roof replacement in the amount of \$165,000.00. Bid documents will be available March 23<sup>rd</sup> and the bidding schedule will be posted.

<u>Streets & Property:</u> The Committee is reviewing the applications received for the part time position and interviews will be conducted.

The Streets are being prioritized for repairs. Penn Dot is looking into Sugarloaf Avenue drainage problems. Vice President Schneider noted Brookhill by Twain Circle has two major areas of standing water. Patching is underway throughout the Borough.

WREN Grant in cooperation with the Friends of the Nescopeck will hold two clinics – one May 2<sup>nd</sup> for rain barrels and stormwater management and one May 30<sup>th</sup> for rain gardens used in landscaping and planting at the Borough building.

The TreeVitalize Grant has been approved in conjunction with the Shade Tree Commission to replace trees at Whispering Willows Park as part of an ongoing program.

The Borough currently has applications in for two LSA grants. \$273,000.00 has been applied for Grant Street and Edge Trail stormwater management and paving. \$272,000.00 has been applied for Sugarloaf Avenue sidewalks and stormwater management as well as pedestrian signage. President Gregory has been in communication with our State Representatives regarding the grants.

A meeting was held today with Valley Vets regarding Hometown Hero Banners which will be available at a cost of \$240.00 per banner.

Penn Dot has provided the Topography and Survey Data for Streetscape to assist in bid preparation at a large cost savings to the Borough.

Two local artists are working on designs for the Welcome Banners. There are over twenty businesses in the downtown area for sponsorship.

Flags will be available to sponsor at a cost of \$50.00 per flag and will be installed by the Valley Vets from Memorial Day through Labor Day.

Shade Tree: A meeting will be held Friday, March 20<sup>th</sup> to coordinate efforts with Parks & Recreation.

<u>COG:</u> The March 20<sup>th</sup> meeting has been cancelled so members may attend the Marcellus Shale presentation.

Police Committee: President Gregory has been working to resolve the ongoing issues with Metro Alert. The program was purchased December 19, 2013 however the software was never installed. He has spoken with the company and Cpl. Rinehimer. The annual license fee is \$1500.00 and the company has agreed to credit the 2015 fee due to the prepayment of 2014 at the time of purchase which was never used. The system will enhance communication between all departments and training will be provided. The LC DA is working on a grant to defray future costs. Discussion ensued.

The Solicitor explained the Delinquent Real Estate Tax Ordinance to Council stating the Tax Claim Bureau collects the payments and remits 95% to the Borough and Tax Claim retains 5%. Under new State law the Borough can collect 100% of the tax with Tax Claim's 5% being paid for by the delinquent taxpayer.

Vice President Schneider stated it is prudent for Council to approve this Ordinance.
