Old Business: Brookhill Feasibility Study for Culvert Replacement has been completed and Multi-Modal Grant must be submitted by July 31st however the Borough has not received a Match Commitment by Brookhill Association.

Reilly Associates and the Borough attempted to meet with all parties involved with Smith Drive however one individual was out of town.

President Gregory noted a resolution is near regarding the water/sewer issues.

<u>Catch-All:</u> Councilwoman Hawk would like an insurance review at the next work session. The Solicitor recommends RFP in September.

Main Street sewer issue has been submitted to the Borough's insurance carrier since the contractor was not given the opportunity to do the work.

<u>Public Comment:</u> Mrs. Sauers – Edge Trail cinders in her driveway and stormwater inlet concerns have not been addressed. The Borough will pursue.

Linda Grencavich questioned whether or not a Dollar General was proposed. No applications have been made to the Borough.
