<u>Catch All:</u> The bathrooms at the park need to be opened prior to start of Little League. The camera installation will be completed in the near future. Internet must be secured for the system at the pavilion. Service Electric will be contacted to provide drop and internet service.

<u>Public Comment:</u> Ron Schadder questioned if Fire & EMS Services will be changed. President Gregory advised the Borough has only held preliminary discussions to determine the options that best meet the needs of the residents. The current Valley Regional contract expires 12/31/17. Mr. Schadder noted Sugarloaf was only able to provide BLS coverage not ALS coverage. President Gregory assured Mr. Schadder the Borough will never be without ALS coverage.

Councilman McKee questioned Mr. Schadder about the extent of the EMA drills during his tenure on Council. Mr. Schadder advised all activities were based on PEMA protocol.

President Gregory questioned Mr. Schadder's statement regarding a fee reduction by Valley Regional since the minutes from November 2007 reflect Chief Balliet requesting an increase in annual payment. Discussion ensued regarding \$22,000.00 annual payments made to Valley Regional and whether they were in conjunction with the purchase of the Attick building.
