Grants: Main Street Streetscape to be completed by the end of October.

Sugarloaf Avenue Phase I & II from Sheetz to Independence Avenue to be bid and awarded spring 2017.

Brookhill Road Improvement Project awarded.

Master Plan will be underway soon. Master Plan Committee includes representatives from Council, CVCO, Friends of the Nescopeck, Downtown Business District, Parks & Recreation and Remembering Ryanne Foundation. Public hearings will be held as well.

The borough is applying for a PA Small Water & Sewer Grant in the amount of \$500,000.00 with a 15% match for stormwater improvements in Luchi Manor.

President Gregory is pleased over \$1,000,000.00 in grant funding has been received under current Council tenure.

Police: Contract negotiations are underway.

New Business: A recommendation has been made to terminate the contract with the Independent UCC Inspector with thirty (30) day notice. The Solicitor will provide RFP for services for Council to consider at October session.
