**Old Business:** Councilwoman Reber questioned if there was resolution to concrete issues with Main Street Streetscape. President Gregory advised warranty on the work has expired and the cause appears to be the utilization of rock salt to treat surfaces in the winter by property owners. Sand is recommended on newer concrete to prevent deterioration.
