<u>Public Comment:</u> Dan Rymond, Conyngham Crimewatch addressed speeding concerns throughout the community. He proposed the addition of Stop signs at Main & Butler Avenue, MainStreet at Sugarloaf Avenue and Main Street at Walnut Avenue.

Council advised Butler Avenue & portions of Main Street are State highways which require Penn DOT studies and approval to implement change. Mayor Marnell stated she can reach out to our State Representative. The Police Committee will be meeting in the near future to discuss concerns.

Linda Grencavich, Main Street, noted speeding is the worst between 6:00 am - 8:30 am and 3:00 pm - 5:00 pm.

Ray Croker, Timber Circle, observed numerous stop sign and speeding violations at Main Street and Sugarloaf Avenue. President Gregory added Johnson's Pharmacy parking lot is an ideal place for police to patrol intersection. Parking situation on Main Street has improved due to painting of yellow curbing as well as "No Parking" stencils on roadway.
